

My Mother's Last Dance

"Is this woman a relative," my mother asked, confused, yet hopeful, "a niece, my nephew's wife?"

The Haitian aid, sent by Hospice at my request, *somebody who speaks French, please*, was lovingly combing my mother's pearly white hair.

When my mother, three months after her ninety-fifth birthday, was diagnosed with pancreatic cancer, the doctor suggested Hospice immediately. "She has six weeks at most," he said.

The aid kissed my mother's forehead and arranged the pillows under her head. "Merci," my mother said.

Troubles started two years earlier, when my mother, who lived on her own, began to have nightly delusions. She'd call me in the morning, saying a man comes at night, takes out the refrigerator and brings a sewing machine; or vice-versa. She complained about the people sent by social services to help with her bath and clean the apartment, "Lazy people, on the phone all the time," and fired them. I discovered also that her refrigerator was filled with uneaten meals.

Rachel Cohen had always been independent and brave. The two of us lived in hiding after my father was taken to a concentration camp during WWII. During Romania's communist regime she worked in a textile plant, and was the first one in the family to be employed after we immigrated to Israel.

She attended *Notre Dame de Sion*, the French convent school, to fulfill my grandparents' hope that speaking French and playing piano would attract a desirable bridegroom.

My parents, excellent dancers, fell in love during their first tango.

At ninety-five my mother still spoke French well, but forgot most of the English she learned after we brought her to the United States.

One day I was surprised to hear her say, bewildered, "I am a hundred years old."

When I tried to change her mind, she became angry, "How would you know, you weren't there when I was born."

A quiet dementia, I thought, but I was mistaken. Kicking and screaming, she fought with me when I said that it would be better for her to live in an assisted living facility. My husband and daughter couldn't convince her either.

"You'll live closer to us," was my final argument, "only a few minutes drive from our house." I think I knew what she wanted. I remembered my grandmother's words; *an old person is a treasure. If you don't have one, buy one.* 

But that was the old country, not America. Five month before I was told she had terminal cancer, I moved my mother to Heritage Park. The day she was diagnosed, we returned to her new home, where she had already made many friends. We arrived during the weekly entertainment; a man sang old tunes accompanied by an electric keyboard. My mother turned toward me and said, "Let's dance." We loved dancing together.

I put away her walker and we danced as always, my mother leading. When we finished, everybody applauded. My mother beamed. She looked so happy, so very happy.

Entries should be STAPLED in the upper left hand corner and pages must be numbered. No paper clips or binders.

Two cover sheets should be included with each entry. Word count must be listed on both cover sheets. Entries that go over the 500 word count will be disqualified. Example: If you submit two essays, each essay will have two cover sheets.

**Cover sheet 1:** Title of your essay, your name, address, phone number, email, and name of your branch. Word count. Do not staple this cover sheet to your entry.

<u>Cover sheet 2:</u> Title of your essay **ONLY**, with word count, stapled on to your essay.
